What are cookies?

The stored information can be sent back to the server during your next visit. Cookies are necessary to provide you with a pleasant user experience on the Website.

Functional cookies

Functional cookies are essential for the proper functioning of the Website. Without these cookies, the Website cannot operate optimally. These cookies cannot be disabled. There is a distinction between session cookies (deleted after you leave the site) and persistent cookies (stored to prevent repeated actions, such as re-entering data or reselecting preferences). Data collected through these cookies is not shared with third parties.

Analytical cookies

Analytical cookies help improve the Website by providing insights into its usage, such as search queries, page load times, and click behaviour. Some analytical cookies may be placed without consent; others require explicit permission.

Google Analytics: The Website uses Google Analytics to monitor and report on visitor interactions. A persistent cookie is placed to identify the web browser. Only data that may be shared under the GDPR is provided to Google. No consent has been given for

Google to share this data with third parties. IP addresses are anonymised. Google may be required by law to provide data to third parties.

Social media cookies

The Website may contain buttons from social networks such as Facebook or Twitter. These work through code from the social media companies themselves, which can place cookies. Please refer to the privacy policies of these companies for more information.
