Privacy Policy - Praktijk Rozendaal-Doest

This is the Privacy Policy of Praktijk Rozendaal-Doest (hereinafter referred to as "Praktijk Rozendaal-Doest"), registered with the Dutch Chamber of Commerce under number 76699285. Praktijk Rozendaal-Doest can be contacted at oc.rozendaal@gmail.com.

This Privacy Policy explains how Praktijk Rozendaal-Doest collects, uses, shares, and protects data in relation to its services. Data is collected when the services of Praktijk Rozendaal-Doest are used. Personal data is processed in accordance with the General Data Protection Regulation (GDPR), the Dutch implementing legislation based on the GDPR, and other applicable privacy laws. This Privacy Policy applies to all individuals who use the services of Praktijk Rozendaal-Doest.

By using the services, it is understood and accepted that information will be collected and used in accordance with this Privacy Policy.

What data is collected?

- Personal data provided directly by the user, such as name, date of birth, address, telephone number, and email address.
- Data collected via the Praktijk Rozendaal-Doest website (see also the separate website privacy policy).

Purposes of data processing

When using the services, the user provides certain data, for example, when scheduling an appointment. This may include name, email address, telephone number, and payment details. All collected information is used for:

Sharing of information

Personal data will not be rented or sold to third parties, unless explicit consent has been provided or in order to comply with a legal obligation.

Legal requests and prevention of harm

On the basis of a legal request, Praktijk Rozendaal-Doest is entitled to access, store, and/or share information (for example, pursuant to a search warrant, court order, or subpoena). Information may also be stored and shared when necessary to detect, prevent, or address fraud or other illegal activities, or to protect Praktijk Rozendaal-Doest, clients, and third parties.

Security

Praktijk Rozendaal-Doest has implemented appropriate technical and organizational measures to protect personal data against unlawful processing.

Retention period
